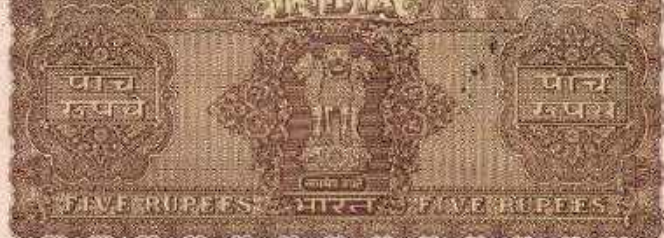

Twenty-one clear days' notice for the Board Meeting shall be given in writing to all the members of the Trust

- a) Every Trustee shall from time to time in writing specify to the Board of Trustees or such person as may be appointed by the Trustees on their behalf, his address to which notices and other communications from the Trust may be sent, which shall be entered

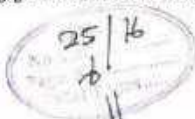

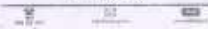
