

AND WHEREAS the authors of the Trust are transferring to the TRUSTEES of this Trust a sum of Rupees Three Thousand and Three only (Rs.3,003) from the nucleus of the Trust

NOW THIS DEED OF TRUST WITNESSETH

1. It is hereby declared and constituted by the Authors that a Trust known as the GANDHINAGAR WELFARE TRUST shall be established for the running of the school for the children of the locality


 - a) The expression "Trust purposes" shall mean the "Trust purposes" set out the Schedule hereto

5. The Trustees shall have and may exercise all or any of the following powers as they may consider necessary or desirable for and in connection with Trust purposes
 - a) To purchase, hire, take on lease lands and movable or immovable properties, accept gifts or loans on such terms and conditions and (where applicable) subject to payment of interest or otherwise as the Board of Trustees may consider necessary or desirable

 - d) To institute and conduct or defend any legal or other proceedings in the name of the Trust or against the Trust as the case may be and to engage counsel or attorneys and to give them such vakalats or power of attorney as may be necessary from time to time

- e) To frame rules and bye-laws for the conduct of the business of the Trust and its transactions
PROVIDED that the above powers are not to be construed by way of limitation and shall not prejudice or restrict the generality of the powers of the Board of Trustees
- 6. To facilitate the administration and quick despatch of business the Board of Trustees shall appoint an Executive Committee of FIVE MEMBERS as outlined in the schedule hereto and the Board shall delegate to this Executive Committee such of the powers as deemed necessary
- 7. The Trustees shall be entitled to receive and be paid out of the Trust Fund all out of pocket, including travelling and other expenses reasonably incurred by them in connection with Trust matters and attending any meeting of the Trust which in the opinion of the Trustees is reasonable
