- e) To frame rules and bye-laws for the conduct of the business of the Trust and its transactions
PROVIDED that the above powers are not to be construed by way of limitation and shall not prejudice or restrict the generality of the powers of the Board of Trustees
6. To facilitate the administration and quick despatch of business the Board of Trustees shall appoint an Executive Committee of FIVE MEMBERS as outlined in the schedule hereto and the Board shall delegate to this Executive Committee such of the powers as deemed necessary
